Notice is hereby given that the Detroit Regional Convention Facility Authority (DRCFA) is soliciting bids for **Kitchen Hood Exhaust Inspection and Cleaning** per the terms and conditions of the Request for Proposal (RFP).

Bidders are highly encouraged to attend the pre-bid meeting and site visit on **May 23, 2023 at 10:00 am at Huntington Place – Detroit**, One Washington Blvd, Detroit, MI 48226. Meet at the Main Entrance (Joe Louis statue). Bidders are responsible for understanding the RFP and service requirements prior to the meeting. Bids shall be prepared in accordance with specifications outlined in the RFP. Bid responses shall be on forms furnished by the DRCFA in this RFP. The DRCFA is exempt from all taxes. Bidders must provide Iran Linked Business disclosure in compliance with Public Act 517 of 2012 and attach this information to the bid proposal. The bid proposal must be accompanied by a sworn and notarized statement that their business is NOT an Iran Linked Business.

A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so requested prior to the time specified above for opening of bids.

Bid submittals must be received on or before **June 2, 2023 at 2:00 p.m. local time** via email to [purchasing@drcfa.org](mailto:purchasing@drcfa.org) or mailed to Detroit Regional Convention Facility Authority, One Washington Blvd, Administrative Offices, 3rd Floor, Detroit, MI 48226, Attention: Purchasing Department, Ms. Laura Harrington. No allowance will be made for late delivery for any reason. Late bids shall not be opened nor returned to bidder.

Bids will be publicly opened on **June 2, 2023 starting at 2:00 p.m.**, local time, by the DRCFA, at One Washington Blvd, Administrative Offices 3<sup>rd</sup> Floor, Detroit, MI 48226. Interested parties may join in person. RFP evaluation and award subsequently will be made (only upon unanimous decision) by the Board of Directors at the DRCFA. The successful bidder shall be required to enter into a contract with the DRCFA.

This purchase is sales tax exempt. The Authority will provide a sales tax exemption form upon request.

The right to reject any or all bids, either in whole or in part, split the award, to award to other than the low bid, or to waive any informalities or irregularities therein, is reserved by DRCFA. The Authority will not consider nor accept a bid received by the Board of Directors after the deadline date and time specified in RFP documents.
