Proposals shall be prepared in accordance with specifications outlined in the ITB. Submittals shall be on forms furnished in the ITB. Proposers must provide Iran Linked Business disclosure in compliance with Public Act 517 of 2012 and attach this information to the bid proposal. A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so, requested prior to the time specified above for opening of proposals.

The DRCFA will not consider nor accept a proposal received by the DRCFA after the deadline date and time specified in ITB documents. Late bids shall not be opened nor returned to bidder. Faxed or mailed bids shall not be accepted for any reason.

Proposals will be publicly opened on **May 7, 2026 starting at 2:00 p.m. EST** at Huntington Place, One Washington Blvd, Detroit, MI 48226. Interested parties may attend in person in Conference Room 350. ITB evaluation and award subsequently will be made by DRCFA's Board of Directors. The successful bidder(s) shall be required to enter into a contract with the DRCFA.

The DRCFA reserves the right to reject any or all bid proposals, either in whole or in part, to split the award, to award to other than the low-cost bid, to waive any informalities or irregularities, and to accept bid alternates. The DRCFA also reserves the right to award a contract in any manner deemed by the DRCFA, in the DRCFA's sole discretion, to be in DRCFA's best interests.
