Proposals shall be prepared in accordance with specifications outlined in the RFP. Submittals shall be on forms furnished by the DRCFA in this RFP. Proposers must provide Iran Linked Business disclosure in compliance with Public Act 517 of 2012 and attach this information to the bid proposal. The bid proposal must be accompanied by a sworn and notarized statement that their business is NOT an Iran Linked Business. Each Bid Proposal must be accompanied by a certified check, cashier's check, or a satisfactory surety bid bond in an amount not less than five percent (5%) of the total Bid Proposal price as guaranty. No Bid Proposal shall be considered unless it is accompanied by the required guaranty. Each check shall be made payable to *Detroit Regional Convention Facility Authority*.

Late bids shall not be opened nor returned to bidder. Faxed bids shall not be accepted for any reason. A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so requested <u>prior</u> to the time specified above for opening of proposals.

Proposals will be publicly opened on **October 13, 2023, starting at 2:00 p.m.,** local time, by the DRCFA, at One Washington Blvd, Detroit, MI 48226. Interested parties may join in person upon arrival to the Administrative Offices on the 3rd Floor. RFP evaluation and award subsequently will be made by the Board of Directors at the DRCFA. The successful bidder(s) shall be required to enter into a contract with the DRCFA.

DRCFA is exempt from sales or use tax for all direct purchases of tangible personal property, but bidders may be responsible for state sales or use taxes for purchased materials that are used and affixed by bidder to real property owned by DRCFA. The Authority will provide a sales tax exemption form upon request.

The right to reject any or all proposals, either in whole or in part, to split the award, to award to other than the low bid, or to waive any informalities or irregularities therein, is reserved by DRCFA. The Authority will not consider nor accept a proposal received by the DRCFA after the deadline date and time specified in RFP documents.
