Notice is hereby given that the Detroit Regional Convention Facility Authority (DRCFA) is soliciting bids for **Waste Removal & Recycling Services** per the terms and conditions of the Request for Proposal (RFP).

Prospective bidders must first log in to the site and search the “Open Solicitations” tab for this project. Bidders are encouraged to attend the pre-bid meeting on **January 4, 2024, at 10:00 am at Huntington Place – Detroit**, One Washington Blvd, Detroit, MI 48226. Bidders are responsible for understanding the RFP requirements prior to the meeting. Bids shall be prepared in accordance with specifications outlined in the RFP. Bid responses shall be on forms furnished by the DRCFA in this RFP. Bidders must provide Iran Linked Business disclosure in compliance with Public Act 517 of 2012 and attach this information to the bid proposal. The bid proposal must be accompanied by a sworn and notarized statement that their business is NOT an Iran Linked Business.

A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so, requested prior to the time specified below for opening of bids.

Bid submittals must be received on or before **January 23, 2024 at 2:00 p.m. local time** via email to purchasing@drcfa.org or mailed to Detroit Regional Convention Facility Authority, One Washington Blvd, Administrative Offices, 3rd Floor, Detroit, MI 48226, Attention: Ms. Laura Harrington, Purchasing Director. No allowance will be made for late delivery for any reason. Late bids shall not be opened nor returned to the bidder.

Bids will be publicly opened on **January 23, 2024, starting at 2:00 p.m.**, local time, by the DRCFA, at One Washington Blvd, Room 352, Detroit, MI 48226. Interested parties may join in person. RFP evaluation and award subsequently will be made by the Board of Directors at the DRCFA. The successful bidder shall be required to enter into a contract with the DRCFA.

The Authority is exempt from sales or use tax for all direct purchases of tangible personal property. The Authority will provide a sales tax exemption form upon request.

The right to reject any or all bids, either in whole or in part, split the award, to award to other than the low bid, or to waive any informalities or irregularities therein, is reserved by DRCFA. The Authority will not consider nor accept a bid received by the Board of Directors after the deadline date and time specified in RFP documents.
